## Mission and History

The Brandywine Conservancy & Museum of Art preserves and presents elements of art and nature that highlight the extraordinary beauty of the Brandywine region in Pennsylvania and Delaware.

In the mid-1960s, Chadds Ford, Pennsylvania—a rural community nestled in the historic Brandywine Valley—faced threats of massive industrial development. The impact would have dramatically changed the character and future of this area. Appreciating the need for rapid action, a group of local residents bought endangered land and founded the Brandywine Conservancy in 1967. Today, the Conservancy holds more than 500 conservation easements and has protected more than 70,000 acres from development. The Conservancy is a leading local and national advocate for responsible land use, open space preservation and water protection. The Conservancy focuses on integrating conservation with economic development to permanently protect and conserve natural, cultural and scenic resources. Shortly after the founding of the Conservancy, the Brandywine Museum of Art opened in a former grist mill on the banks of the Brandywine Creek in 1971. Today the Museum has an international reputation for its unparalleled collection of American art, with particular strengths in the three generations of Wyeth family artists. The collection also boasts a comprehensive array of American illustration, still life and landscape paintings, along with fine examples of American Impressionism and a growing body of work by contemporary artists.

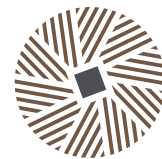
